Latest Update

CNC subsidiaries continue to pursue opportunities

2020 has been a challenging year for all businesses' concerns across our state and across the nation. With travel and gathering restrictions in place, It has caused Chitina Native Corporation to evaluate how business is conducted from Board Meetings to Project Marketing and general employee operations. We have found ourselves on-line for most meetings and continue to distance where we can socially. 2020 has been a strong year for Chitina Native Corporation overall. As you will read in the following Newsletter update, your corporation has adapted and continues to pursue our business goals. Our complete 2020 financial performance information will not be available until early 2nd qtr. 2021 yet all indications look to be another record-setting year.

Chitina Electric Inc.

Even though Chitina Electric Inc. (CEI) officially graduated the SBA 8(a) program in April of 2020, they continue to see substantial work activity through on-going and existing federal contracts. The Chitina Electric, Inc./ AMES 1 Joint Venture has proven a great opportunity for CEI to build relationships and past performance with the United States Army Core of Engineers, nation wide. CEI will continue working on some of these projects for the next few years or as field projects come to an close.

CEI has also long pursued the idea of Chitina utilizing Hydro-Electric power to offset the high cost of diesel fuel for the region. For 2020, CEI has seen major advancements with this effort to include a substantial USDA grant award. With the Alaska Energy Authority's support CEI is continuing to validate the 5 mile Hydro-Electric project. In partnership with the Ahtna Intertribal Resource Commission, CEI will continue to look at the project economics to determine the best path forward.

Chitina Diversified Services

As CNC's newest operating subsidiary Chitina Diversified Services (CDS) has recently been awarded construction work through the SBA 8(a) program from the United States Army Corps of Engineers. The scheduled contract work is set to begin early 2021 and go on for approximately a year and a half in Brooklyn, NY. "As of right now we are working to staff up the site and prepare to mobilize supporting project infrastructure" says Ed Herndon, GM for CDS.

This is an exciting opportunity as it shows the long term sustainable approach that CNC will use to pursue federal contracts in the SBA 8(a) program. With seven more years in the 8(a) program CDS is ready to work and is actively marketing itself to different agencies for construction and services contracts.

Lands — O'Brien Creek/ Haley Creek update



A Joint task force made up of members of Ahtna Inc, Chitina Native Corporation and the Native Village of Chitina have created a working group to address regional concerns.

With and increase in activities such as dip-netting, tourism, and state and local work have caused concerns for regional stakeholders. The task force has focused in on prioritizing land, cultural, trespass and resource items. With spring around the corner and access to O'Brien Creek and Haley Creek increasing, the group is working steadfastly to prepare and communicate priorities that convey that our lands, culture and history are to be respected.

Taral Enterprises

Taral not only operates the lone Chitina store but operates the local gas station, provides park and sanitation services and takes campground/RV reservations for Chitina. While providing these services Beth Kelly (GM for Taral) strives to keep her and her employees safe during this pandemic. Taral is continually reminded that if an employee gets exposed to COVID – 19 it could mean shutting down the only store in Chitina. Beth takes this seriously and has created procedures to ensure all who enter the store are safe and works hard to keep the Chitina store open for all.

For 2020 Taral has seen record reservations and an uptick in sales across the board, with the exception of gasoline sales. Taral continues to look for ways to add to its services and most recently opened a new 1 mile tent platform spot. The focus remains on growing local products and services to meet peak summer demand.

Chitina Real Estate Investments

The property rental market in Anchorage has been somewhat flat for 2020 and there hasn't been much activity with all three residential properties fully leased. Chitina Real Estate Investments (CREI) continues to be busy with the addition of the new Anchorage location, 821 N St.. This property was purchased to give Chitina Native Corporation a footprint in Anchorage and to support our subsidiaries growth. With CNC subsidiaries as the primary lessors, subsidiary's work has increased with additional personnel for those offices. Residential/Commercial Property will continue to be an area of interest for CNC and as property markets soften we will look for the right investment and time to add to our portfolio.

If you have ever called the Chitina Native Corporation phone line or emailed CNC, odds are you have talked with Loni Lohse. Loni has worked at Chitina Native Corporation for 29 years and during that time she has worked with and supported the CNC Board of Directors and employees alike.
